It is a condition that you must be a member of a club to have a vehicle on the Club Permit Scheme (CPS). Vehicles owned by non-financial members cannot be driven and CHVC must advise VicRoads/DoT that a member is not financial by 14 May each year. **To maintain a vehicle on the CPS with CHVC, a member must attend 3 club meetings and 2 club runs annually.**
